

General Disclosure for Programs Meeting Licensure or Certification Requirements

PROGRAM: Education, B.S.

Includes Early Childhood Education, Elementary Education, and Middle School Education

PROGRAM: Education, MAT

Includes Early Childhood, Biology, Chemistry, Earth/Space Science, Physical Science, Physics, and Mathematics

As set out in the 1 November 2019 Final Rules in the Federal Register, the U.S. Department of Education requires that all institutions make public information regarding a program's ability to meet the licensure or certification requirements for a particular state.

The programs leading to teaching licensure at Stevenson University have been designed to meet the licensure/certification requirements in Maryland as well as prepare students to apply for licensure/certification exams in the State of Maryland. Students who intend to return or move to any state other than Maryland are advised to review the professional licensure/certification disclosures pertaining to their program. The chart below provides professional licensure/certification disclosure information for the Stevenson University Bachelor of Science Degree in Education and the Masters of Arts in Teaching Degree. The National Association of State Directors of Teacher Education and Certification (NASDETC) Agreement facilitates the mobility of educators among the states that are members of NASDETC and have signed the agreement. **As of March, 2022, all 50 states and the Department of Defense Schools have signed the NASDETC Agreement.** Although there may be conditions applicable to individual states, the Agreement makes it possible for an educator who completed an approved program and/or who holds a certificate or license in one jurisdiction to earn a certificate in another state or jurisdiction (NASDETC, 2022).

All states will require an application for teaching using the Maryland Teaching License and proof of an approved Educator Preparation Program. States listed below as "Does Not Meet Licensure/Certification Requirements" may require an additional review of the requirements for certificate and associated licensure assessments. Typically, individuals are asked to provide the applicable State Department of Education with evidence of completing an approved teacher preparation program (transcripts) along with satisfactory passing scores on relevant assessments, then licensure is often granted. Students should use the State Department of Education links below to identify any materials or additional requirements for licensure/certification in the state(s) in which they plan to teach.
